HISTORY (Dates reviewed by City council, Policy Committees, Boards and Commissions, or Staff. Summarize pertinent comments. ATTACH MINUTES OF COUNCIL MEETINGS, POLICY COMMITTEES AND BOARDS AND COMMISSIONS.)

The Office of International and Immigrant Affairs (OIIA) was created to facilitate the successful integration of immigrants and refugees into Aurora's civic, economic and cultural life and to manage international relations and protocol activities for the city. To guide this office, a Comprehensive Strategic Plan was proposed by staff and approved by the City Council in September 2015. Since its adoption in 2015. The plan sets forth a number of innovative programs and initiatives aimed at integrating the local immigrant and refugee population. Since its adoption in 2015, OIIA has been working to develop and implement those programs and initiatives in collaboration with local nonprofits and key community partners. Many of these programs have been recognized by national and international organizations, including the 2017 City Cultural Diversity Award by the National League of Cities and the 2017 Metro Vision Award by the Denver Regional Council of Governments. As a result of these achievements, OIIA has been approached by "Welcoming America" and "Cities for Citizenship," two of the most important national networks working in the immigrant integration space in the United States. Both organizations have invited Aurora to become an official member. At the January Public

Relations, Communications, Tourism, Libraries, Boards and Commissions and Citizens Groups Policy Committee, the Committee requested that OIIA provide information at the February meeting regarding Welcoming American and Cities for Citizenship.

At the February meeting of the Committee, they recommended joining Welcoming Cities at the \$1,000 level and Cities for Citizenship and moving this forward to Study Session.

ITEM SUMMARY (Brief description of item, discussion, key points, recommendations, etc.)

Since 2015, the Office of International and Immigrant Affairs has been working to achieve the objectives outlined in the Comprehensive Strategic Plan, including programs/initiatives in the areas of civic engagement and citizenship. Similarly, "Welcoming America" and "Cities for Citizenship" are two nationally recognized organizations promoting civic engagement, naturalization and citizenship efforts among immigrants and refugees in multiple cities across the U.S. Becoming an official member of both organizations would allow OIIA and the city of Aurora as a whole to access technical assistance, resources, best practices, and educational & training opportunities for OIIA and city staff. A representative of "Welcoming America" was available at committee to discuss the work of each national networks.

Welcoming America information:

Launched in 2009, Welcoming America is a non-partisan organization that provides assistance to cities and towns to become more inclusive toward immigrants, refugees and all residents. Its municipality program offers learning exchanges on national and international levels. More than 100 U.S. cities are active members at this time. The minimum requirement to join Welcoming America is to pay annual fee of \$125.00 and to approve a city resolution to officially join this network (see attached city resolution sample and background info about Welcoming America). At the February meeting of the Public Relations, Communications, Tourism, Libraries, Boards and Commissions and Citizens Groups Policy Committee, it was suggested joining Welcoming Cities at the \$1,000 level.

Cities for Citizenship information:

Cities for Citizenship (C4C) is a major national initiative aimed at increasing citizenship among eligible U.S. permanent residents and encourages cities across the country to promote citizenship efforts among immigrants and refugees. More than 50 U.S. cities currently participate in this national network. The only requirement to join Cites for Citizenship (C4C) is a \$750 annual membership fee, fill out an application, and make a commitment to support citizenship efforts in the city.(please see attached additional background info about C4C).

WHEREAS, the City of Aurora's Office of international and Immigrant Affairs has been working toward the implementation of this plan for the past two years; and

WHEREAS, many of these new programs and initiatives have been recognized as good practice in local government by national and international organizations; and

WHEREAS, Welcoming America has been promoting the inclusion and participation of immigrants and refugees in the civic and economic life of U.S. cities; and

WHEREAS, Welcoming America's goals and objectives are fully aligned with the current city efforts in the area of immigrant integration.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AURORA, COLORADO:

Section 1. The Aurora City Council declares its support in officially joining the Welcoming America Network. The City Council believes that joining the network will help to unite our community and ensure that all are welcome here. The City Council urges all residents of Aurora to do their part in reaching out to and welcoming all who live in and visit our City.

WELCOMING PROCLAMATIONS AND RESOLUTIONS

Many communities utilize public Welcoming proclamations or resolutions by elected officials to affirm their support for the principles of being a welcoming community. Additionally, some communities will issue a public statement in conjunction with Welcoming Week.

Welcoming America local government members commit to a proclamation or resolution, and while many choose to do so to announce their participation in the Membership Network, the requirement may be met any time within a reasonable period of becoming a member.

Whether a community wishes to issue a proclamation or resolution merely as a symbolic act or more formally, to become a recognized Welcoming City or County and Member, we ask that you please reach out to Welcoming America before doing so, so that we can best coordinate with you around proactive communications, as well as to avoid potential pitfalls that can come with public declarations.

In general, it's best to:

- Review sample resolutions from other communities for reference
- Speak to voting members of the municipal body in advance to make sure their questions about the resolution are answered and there is nothing standing in the way of their support
- Check-in with the official administering the public meeting to see how well attended it will be and who has signed up to make public comment
- Invite diverse allies of the resolution to attend to support it, watch it be approved, and pose for any photo ops, post on social media
